NEXUS REVIEWS

To determine potential income tax and sales/use tax filing requirements based upon your business' current and proposed operations.

STATE TAX OVERVIEW (OR COMPLIANCE REVIEW)

- Income tax and/or sales use tax focused.
 - Begins with a Nexus Review to determine potential income/franchise tax return filing obligations
- > For income/franchise tax, an examination of revenue streams/state activity/current apportionment to determine possible changes that will result in tax savings
- For sales/use tax, review tax collection and filing requirements (and use tax reporting requirements) and potential tax exposure/liability, coupled with a review of current filings to determine if these are correct.
 - Includes a review of taxes collected or reported on sales/services and whether a restructuring of the transactions can minimize the taxes
 - Review potential over-collection/under-collection of the tax to determine potential refunds/exposure
 areas
 - Review of documentation procedures (is the company maintaining documentation to support non-taxed sales (i.e., exemption certificates) and to sufficiently defend itself in the event of audit)
 - Recommendations for improvement

VOLUNTARY DISCLOSURES

- > If a liability is determined with a state, voluntary disclosures are often done to "come clean" -
 - Determine tax that may be due a state, pay the tax and interest; typically can avoid penalties and limit look-back periods
 - Evaluate the pros and cons of approaching a state under a voluntary disclosure program versus applying for tax amnesty, if an amnesty program is in progress

AUDIT DEFENSE & APPEALS

For anyone currently under audit or about to be audited by a state or local jurisdiction:

- Assistance provided with pre-audit strategy to minimize the work involved in the audit,
- > Review of auditor requests
- > Review of audit workpapers to determine errors/offset liabilities with refunds
- Negotiate with/act as liaison with auditors
- Ultimately appeal the audit determination to the Tax Commissioner

BUSINESS PROFESSIONAL AND OCCUPATIONAL LICENSE (BPOL) TAX PLANNING

- > Refunds and tax savings strategies, particularly for companies that sell hardware/software/services to commercial or governmental clients
- Review of current filings, recommendations as to ways to minimize the tax and obtain refunds for prior periods

LOCALTAX PLANNING AND CONSULTING

In addition to BPOL planning:

Review all local tax filings (real and personal property) to determine possible areas for savings or exposure

TELECOM TAX REVIEW

For telecommunications companies (telcos, ISPs, web hosting providers, etc.)

- > Review taxes collecting from customers to determine if correct
- Review taxes paid to vendors to determine potential overpayments/underpayments
- > Review BPOL filings to determine potential savings

TAXABILITY STUDIES

> Review of products/services both sold and purchased and determination as to the proper tax status

LIABILITY &/OR REFUND REVIEWS

- Explained under State Tax Review determine underpayments and/or overpayments of tax
- Assist with getting refunds from vendors/the states

BAD DEBT REVIEWS

While bad debts usually are accounted for properly for income tax purposes, businesses often do not have a process in place to accurately reflect bad debt write-offs for sales tax purposes. Plus, states' rules regarding write-offs vary causing confusion and inappropriate treatment of write-offs. Refunds may be obtained, or liabilities determined to be due (and cleared up) through a bad-debt review.

MANUFACTURING/R&D EXEMPTION REVIEWS

- Review operations to determine whether taking full advantage of exemptions for manufacturing and research and development
- Possible refund opportunities or may result in potential liabilities due
- Provides guidance and improved tax compliance based upon actual operations on a going-forward basis

DISTRICT OF COLUMBIA QUALIFIED HIGH TECHNOLOGY COMPANY EXEMPTION REVIEWS

> Review operations to determine whether your business qualifies for the exemptions/tax credits that the District of Columbia offers to certain types of technology businesses that do business in and have employees in the District

CREDITS & INCENTIVES

For businesses operating in multiple jurisdictions/states:

> Review of credits and incentives available at both the local and state level

ABANDONED AND UNCLAIMED PROPERTY COMPLIANCE

Identification and reduction of unclaimed property and compliance with reporting requirements *While not a tax per se, unclaimed property often falls into the tax category as businesses are audited and assessed for failing to comply with state Acceptable Use Policy (AUP) requirements.
